The Notes will be issued pursuant to Chapter 43.180 Revised Code of Washington, and the Internal Revenue Code of 1986, as amended (the "Code"), for the purpose of financing and refinancing a qualified residential rental facility under Section 142(d) of the Code.

The proceeds of the Notes will be used to provide financing and refinancing for the following project:

Proceeds of the Notes will be used to refinance a portion of the financing for the acquisition of land, and the construction and equipping of a 291-unit multifamily housing facility in Bothell, Washington (the "Facility"), and to pay a portion of the costs of issuing the Notes, and to finance additional costs of the construction and equipping of the Facility. Each apartment will be a complete and separate dwelling unit consisting of living, eating and sanitation facilities. A percentage of the total units will be set aside for persons or households with low incomes.

This notice is intended to comply with the public notice requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended.
