- Income and rent limits for Low Income Housing Tax Credit and Tax-Exempt Bond properties are calculated annually by the Federal Department of Housing and Urban Development (HUD) and are provided by the Commission as a customer service. Per IRS regulations, it is the sole responsibility of property owners to use the correct limits.
- Properties with additional funding from other city, county, state, or federal programs may be required to use lower rent and income limits than the HUD limits listed here.
- Maximum rent limits must include the actual or estimated cost of utilities paid by the resident.
