IMPORTANT NOTES:

1. The limit chart identified for each property is based on the Bond Closing and/or PIS date shown.
2. Income and rent limits for Low Income Housing Tax Credit and Tax-Exempt Bond properties are calculated annually by the Federal Department of Housing and Urban Development (HUD) and are provided by the Commission as a courtesy. Per IRS regulations, it is the sole responsibility of property owners to use the correct limits.
3. Properties with additional funding from other city, county, state, or federal programs may be required to use lower rent and income limits than the HUD limits listed here.
4. Maximum rent limits must include the actual or estimated cost of utilities paid by the resident.
5. *Properties with an asterisk (*) by their name have an alternate date for income determination listed in Bond Closing or PIS date.
