## Verification of Farm Work Status Instruction

**Purpose:** At properties with a Farmworker Commitment, this form is to verify an applicant's eligibility by obtaining information from the Farm Work employer.

**General:** This form should be the first step to verifying the eligibility of Farm Work Households. This form may be used in conjunction with the Farm Work Status Verification/Clarification by Telephone form.

## Specific Instructions:

- Use this section to document when the verification was sent.
   Must document three attempts over a two-week period before moving to an alternate verification format.
- 2. Enter the name and address of employer.
- 3. Enter the name and address of property sending the request.
- 4. Enter the household name and household unit number.
- 5. Enter the Managers name and contact phone number.
- 6. The Applicant/Resident prints name, enters last four digits of Social Security number, signs and dates form. \*
- 7. The employer completes this area. Any missing or unclear information should be obtained with Verification of Farm Work Status Telephone Verification/Clarification form.

\* **Note:** For privacy reasons, a resident may elect not to provide his/her Social Security number on this form. Residents who do not provide their Social Security number should sign Certification #2 on the *Identification Certification* form.
