Proceeds of the Bond are expected to be loaned to Wyatt and Lauren Sitton to finance a portion of the costs of acquiring approximately 324.30 acres of agricultural land located 7.5 miles west of Washtucna, WA 99371 and 1/2 mile south of State Route 26 on the West side of Theil Road, north of East Hampton Rd. All land, property, fixtures, improvements and equipment financed with proceeds of the Bond will be used for farm and agricultural purposes. The Bond will be issued pursuant to RCW 43.180.290 for the purpose of providing farming property for a first-time farmer pursuant to Section 147(c)(2) of the Internal Revenue Code of 1986, as amended (the "Code").

The public is invited to attend the hearing and make written or oral statements concerning the proposed plan of finance for the Bond and the project to be financed. This notice is intended to comply with the public notice requirements of Section 147(f) of the Code.
